### 1.0 GENERAL

### 1.1 Summary

Contractor shall furnish, install and finish environmentally friendly wallcovering as specified in the contract documents.

### 1.2 Sample

Contractor shall submit for the architect's approval - a sample of each texture, type or color to be installed.

### 1.3 Compliance

Submit certification that the manufacturer's wallcovering meets the architect's specifications. Submit documentation that the manufacturer's wallcovering is fire rated Class "A".

### 1.4 Warranty

Contractor will supply the manufacturer's written warranty against defects in workmanship for 5 years from date of installation. Submit manufacturers written warranty.

### 1.5 Delivery, Storage and Handling

All necessary materials for installation including wallcovering, primer and adhesives must be delivered to the job site undamaged. All containers are to be clearly marked with the manufacturers identification label. Store wallcovering rolls and materials in a clean, dry area where temperature and humidity remain constant and within the manufacturers specifications.

### 1.6 Project Conditions

Environmental conditions must remain constant and over 65 degrees Fahrenheit for at least four days before and throughout the installation and 4-7 days thereafter. Walls shall be finished to the Architect's specification and be free of surface defects and dirt. The Contactor for the installation process must provide sufficient lighting and access.

### 2.0 PRODUCTS

### 2.1 Vinyl Wallcoverings

All vinyl wallcoverings specified and installed shall meet the latest Federal Specifications CCC-W-408-D and CFFA-W-101-D standards for Vinyl Coated Fabric Wallcovering. All Type I and Type II wallcoverings specified shall contain mold and mildew inhibitors and pass the ASTM-G21 testing for mold and mildew resistance. The ASTM-E84 test must be passed with the wallcovering mounted to common gypsum wallboard.

### 2.2 Flame and Smoke Characteristics

The manufacturer shall certify that the vinyl wallcovering supplied meets Federally specified limits for flame, smoke development and flash over according to the required ASTM-E84 and NFPA286 tests.

### 2.3 Test Accreditation

All product testing for compliance with Federal Specifications shall be performed and evaluated by one or more of the following independent and accredited testing companies: Intertek Testing Services NA, Inc.

### 2.4 Adhesives and Primers

Adhesives and Primers used must be of the type designed for vinyl wallcoverings. Adhesives and Primers must contain mildew inhibitors. See manufacturer's recommendations for commercially available products.

### 3.0 EXECUTION

### 3.1 Inspection

- 1. The Contractor shall provide a complete copy of DreamScape's current Hanging Instructions to the installer pertaining to the installation of the wallcovering. ALL INSTALLATIONS MUST CONFORM TO MANUFACTURERS CURRENT INSTALLATION INSTRUCTIONS AND PRODUCT TECHINICAL INFORMATION.
- 2. All labels shall be checked for accuracy by the installer to insure that the shipment is received as ordered.

3. If no defect is evident before installation, the material should be inspected after three (3) panels are installed. If any defect is evident at this time (or any point of the installation) no further material should be applied and Contractor should be contacted IMMEDIATELY.

### 3.2 Surface Preparation


- A. All hanging surfaces must be clean, smooth, dry, undamaged, free of mold, mildew, grease or stains, and structurally intact. All loose paint and other wallcoverings must be removed. If moisture is present, immediately identify and eliminate the source(s) of the moisture and verify that all wall surfaces are completely dry before proceeding.
- B. Any mold or mildew MUST be removed from walls and hanging surfaces prior to installation. Walls should not contain in excess of 4% residual moisture content. A moisture meter should be used to determine moisture content. Moisture infiltration and accumulation can lead to mold or mildew growth and must be corrected PRIOR to the installation of the wallcovering. This product is intended for use in buildings that are properly designed and maintained to avoid moisture infiltration, condensation and or accumulation at wall cavities and wall surfaces, particularly in warm, humid climates. Old walls shall also be treated with bleach, Lysol and/or other approved, mildew -inhibiting products in order to inhibit further mildew growth.
- C. Proper surface preparation is key to getting great results. To prepare the surface properly, we recommend that you prime all surfaces with a universal, white-pigmented, mold inhibiting wallcovering primer.
- For new drywall construction, a coat of wallcovering primer shall be applied to the surface before application of wallcovering. Use a primer that dries to a solid color to conceal drywall joints.
- E. Use only a lead pencil for marking walls and back of wallcovering. Do not use ballpoint or marking pen, they will bleed through the surface.
- F. Do not install wallcovering unless a temperature above 65° degrees F is maintained in both areas of installation and storage for at least 48 hours prior to installation.

### 3.3 INSTALLATION

- 1. If the application is a textured or non-matched wallcovering pattern, reverse hanging of alternate panels is required to ensure color continuity from strip to strip. If the application is a mural it is recommended that every other panel is rotated 180 degrees when printing to minimize the side-to-side color shift that may occur with each printer.
- 2. Determine whether the pattern match is random, straight across, or drop match. Measure the wall height, allowing for pattern match, add 4 inches, and then cut the wallcovering. It will overlap onto the ceiling and the base approximately 2 inches.



### ARCHITECT'S SPECIFICATIONS



Apply the recommended adhesive to the back using either a pasting machine or a paint roller. Work the adhesive in, to cover the back completely, especially near the edges. Fold each end toward the middle, pasted sides together, aligning the edges carefully so they do not dry out. CAUTION: Do not crease wallcovering. Allow to "relax" for ten minutes (booking). This will allow the adhesive to penetrate the wallcovering fabric, which is important to a successful installation.

- 3. WITH ALL DIRECTIONAL PATTERNS, IT IS IMPORTANT TO LINE UP PATTERNS AT EYE LEVEL ALLOWING ANY DRIFT IN LINEUP TO RUN OFF TOWARD CEILING AND FLOOR. THE STANDARD ALLOWANCE IS ONE QUARTER OF AN INCH UP OR DOWN. IF PATTERN IS LINED UP AT THE CEILING THE PATTERN WILL BEGIN MISALIGNMENT SOONER AND THE GAP WILL BE LARGER. ALSO, MOST PATTERNS WILL BE VIEWED AT EYE LEVEL THEREFORE IT IS THAT AREA THAT NEEDS TO LOOK ALIGNED. IF THERE ARE ANY QUESTIONS ABOUT PATTERN LINEUP, CONTACT SUPPLIER. BE SURE FIRST DROP OF WALLCOVERING IS SQUARE ON WALL BY PLUMBING THE WALL AND USING A LEVEL.
- 4. Avoid burnishing the face of the material. Use a wallcovering brush or a plastic scraper to smooth the wallcovering onto the wall. For optimal durability a liquid topcoat may be used to protect the surface of the wallcovering pattern from stain and abrasion. Caution: a topcoat may significantly reduce the permeability.
- 5. Do not rub. Do not allow adhesive to dry on surface as it may leave a white residue. Wash off excess paste from face of wallcovering as you hang it with a cellulose sponge. The cellulose sponge must be rinsed in clean water after every use. Blot dry with a clean cloth.
- 6. Place the second strip to the edge of the first strip. Tape seams before overlapping and double cutting to avoid getting adhesive on the wallcovering. If paste does get on the wallcovering, clean it off immediately with clean warm water and blot dry with a clean lint less towel. Use a soft bristle brush to wash the ceiling and the baseboard to remove any paste residue. Do not leave any overlap on the seams since the wallcovering will not adhere to itself. Seams should be vertical, have a tight fit, and be free from air and paste bubbles. Seams should not be located closer than 6" to corners.
- 7. After three panels are smoothed to wall surface and excess paste removed, examine the installed panels for color uniformity. Any objectionable variations in colormatch, pattern match, etc...should be immediately communicated to the printer for inspection before proceeding further with installation.
- 8. After installation, the walls and wallcovering should be monitored for potential moisture or vapor infiltration or accumulation. Any such infiltration/accumulation after installation must be promptly eliminated in order to reduce the risk of mold/mildew growth.

### 3.4 CLEAN UP AND COMPLETION

Upon completion of work, remove all surplus material and debris from work site. All work sites must be clean and orderly upon installation crew departure.

### 1.4 Warranty

Contractor will supply the manufacturer's written warranty against defects in workmanship for 5 years from date of installation. Submit manufacturers written warranty.

### 1.5 Delivery, Storage and Handling

All necessary materials for installation including wallcovering, primer and adhesives must be delivered to the job site undamaged. All containers are to be clearly marked with the manufacturers identification label. Store wallcovering rolls and materials in a clean, dry area where temperature and humidity remain constant and within the manufacturers specifications.

### 1.6 Project Conditions

Environmental conditions must remain constant and over 65 degrees Fahrenheit for at least four days before and throughout the installation and 4-7 days thereafter. Walls shall be finished to the Architect's specification and be free of surface defects and dirt. The Contactor for the installation process must provide sufficient lighting and access.

### 2.0 PRODUCTS

### 2.1 Type II PVC-Free Wallcoverings

- 2.1.1 All PVC-free wallcoverings specified and installed shall meet the latest physical requirements as detailed in Federal Specification CCC-W-408-D for Type II Wallcovering.
- 2.1.2 All wallcoverings specified shall be permeable and breathable and tested according to the Wet Cup test (ASTM E96) scoring a minimum of 60 perms for mold and mildew resistance.
- 2.1.3 The ASTM-E84 test must be passed with the wallcovering mounted to common gyp sum wallboard.
- 2.1.4 Wallcovering shall be low voc emitting and meet California Section IAQ 1350 for air quality.
- 2.1.5 Wallcovering must be recyclable and eligible for LEED® credits 4.1, 4.2 (+30% post consumer recycled material).

### 2.2 Flame and Smoke Characteristics

The manufacturer shall certify that the PVC-free wallcovering supplied meets Federally specified limits for flame, smoke development and flash over according to the required ASTM-E84 and NFPA-101 tests.

### 2.3 Test Accreditation

All product testing for compliance with Federal Specifications shall be performed and evaluated by one or more of the following independent and accredited testing companies:

### 2.4 Adhesives and Primers

It is recommended to use Adhesives and Primers designed for permeable wallcoverings. Adhesives and Primers must contain mildew inhibitors. See manufacturer's recommendations for commercially available products.

### CLEANING HD WALLS VINYL BASED DIGITAL MURALS



### 1.0 GENERAL CONDITIONS, REMOVING DAY-TO-DAY SOIL

Ordinary dirt and smudges can be removed with a mild soap and warm water. Clean from bottom of wall upward. Rinse thoroughly with clean water from the top down using a sponge. Deeply embossed wallcoverings need extra attention to remove suds or loosened dirt that may lodge in the embossing. Dry wallcovering with a soft lint free cloth or towel.

For more difficult stains that are only surface deep, the use of a stronger detergent is recommended. Always test an inconspicuous area with the stronger detergent to be sure that the surface and ink are not damaged.

**DO NOT USE** steel wool or powdered abrasives because they can damage the image and textured surface.

**DO NOT USE** solvents, alcohol, pine oil, or cleaners that contain these kinds of products as they can remove the image and damage the textured surface.

When cleaning, always take measures to prevent water from dripping behind molding.

NEVER MIX CLEANING AGENTS TOGETHER, VIOLENT REACTIONS MAY OCCUR.

### 2.0 SURFACE PROTECTION

HD walls prints using durable UV inks that are easily cleaned and highly resistant to abrasion from surface contact.

We recommend DreamGuard Protex 3 for an extra measure of protection where surfaces are exposed to frequent collisions, scuffing, food stains, etc. DreamGuard Protex 3 is a water-based, non-hazardous topcoat that can be applied with commercial liquid laminating equipment as well as with a paint roller. Surfaces treated with DreamGuard Protex3 are significantly more durable in heavy wear areas.







(Suggested Tools: Scissors, Tape Measure, Razor Knife, Ruler, Plastic Card Squeegee, Spray Bottle, Paper Towel)

- 1. Clean the areas to which the film is to be applied, removing all traces of dirt, grime, grease, etc.
- 2. Carefully measure the height and width of the glass surface. Oversize the film up to 3/4" extra material on each side of the film and cut the film to this size.
- Create your own wetting solution by adding 8 drops (a one second short squeeze) of very mild detergent (baby shampoo or dish detergent like "Joy" NOT HAND SOAP) into a 32oz. spray bottle filled with water.
- 4. Lay the cut to size decorative film on a clean flat surface with the release liner up, or have someone hold the piece to be applied for you. Remove the release liner and spray the now exposed adhesive surface thoroughly with the wetting solution. Apply a generous amount of the wetting solution to the glass. The wetting solution prevents the film from sticking to the surface immediately, thereby allowing you more time in which to properly position the film.
- 5. Place the now wet film onto the clean glass surface. Wet the face of the film to be squeegeed. Use the plastic card squeegee and squeegee from the center out towards the edges to remove any air bubbles and wetting solution. Double check that the film is flat and smooth with no remaining air bubbles and water.
- 6. If any bubbles are not removed after Step 4, then squeegee them out towards the closest edge.
- 7. Trim the excess film from the edges of the surface. It is ideal to cut in one continuous movement, using the ruler and razor knife. Use the paper towels for cleaning the glass surface and for the absorption of excess wetting solution around the edges.
- 8. The film may take a few days to dry in order for it to completely adhere to the glass surface.

### PRECAUTIONS:

- The surface to which the film will be applied should be very clean, free of dirt, dust particles and silicone. Make sure there are no dry spots on the film prior to placing it onto the glass.
- Take care that when removing the release liner the film does not roll over onto itself. It will stick together and is difficult to pull apart. Wet the film as the liner is removed!

### TIP TO REMOVE LINER:

To separate the liner from the film take two pieces of scotch tape and stick them opposite each other at one corner...then pull these two pieces of tape apart and the liner will separate from the film. The adhesive surface will now be exposed. Wet this adhesive surface. Do not let the film fall upon itself as it will stick if not wet and it will be hard to separate!

### **SEAMING FILMS**

For windows that are wider than the available width of glassTex<sup>TM</sup> films, Industry standards allow for seaming. Standard Installation for seaming is a but-join type seam. The films are overlapped and cut through with a sharp blade using a straight edge. The excess films are removed. A slight light line may appear. This is normally the width of the blade point. This is acceptable.

### MAINTENANCE, CLEANING AND CARE

glassTex<sup>TM</sup> Decorative Window Films are virtually maintenance free. No special care is necessary. Normal cleaning with a mild window cleaner is ideal. (Windex, Glass Plus, Ammonia and water are all fine with a clean soft paper towel or squeegee). It is not recommended that anything abrasive be used. The frequency of cleaning will not affect the film in any way.

Use of a mold inhibiting primer product and the use of an adhesive containing a mildew inhibitor is recommended.
- 2. All labels shall be checked for accuracy by the installer to insure that the shipment is received as ordered.
- 3. If no defect is evident before installation, the material should be inspected after three (3) panels are installed. If any defect is evident at this time (or any point of the installation) no further material should be applied and your supplier should be contacted IMMEDIATELY. ROYSONS WILL NOT BE LIABLE FOR CHARGES OVER THREE PANELS OF MATERIAL. Roysons will replace defective wallcovering in accordance with the terms of its Limited and Exclusive Warranty. If there are any questions on the following instructions, contact your supplier before proceeding.

### ADHESIVE APPLICATION


Hang wallcovering with a premium quality heavy-duty clear pre-mixed adhesive. Use of a mildew inhibitor in the adhesive is recommended as above instructions. For perforated wallcovering a high quality permable adhesive, such as Roman UltraPlus Pro-550, should be used with the permeable primer. Do not dilute adhesive. Brush an even coat of paste over entire back of wallcovering. Pay particular attention to run over edges so they are sure to be pasted. Book material for ten minutes.

### APPLYING WALLCOVERING TO WALL SURFACE

- If the application is a textured or non-matched wallcovering pattern, reverse hanging of alternate panels is required to ensure color continuity from strip to strip. If the application is a mural it is recommended that every other panel is rotated 180 degrees when printing to minimize the side-to-side color shift that may occur with each printer.
- Determine whether the pattern match is random, straight across, or drop match. Measure the wall height, allowing for pattern match, add 4 inches, and then cut the wallcovering. It will overlap onto the ceiling and the base approximately 2 inches.

- Avoid burnishing the face of the material. Use a wallcovering brush or a plastic scraper to smooth the wallcovering onto the wall. For optimal durability we recommend topcoating with DreamGuard Protex3 to help protect the surface of the wallcovering pattern from stain and abrasion. DreamGuard can be applied with paint roller either before installation or after installation (see separate instructions). If the intent is to perforate the vinyl we recommend coating with DreamGuard prior to perforation for optimal breathability and the highest perm rating.
- Do not rub. Do not allow vinyl adhesive to dry on surface as it may leave a white residue. Wash off excess paste from face of wallcovering as you hang it with a cellulose sponge. The cellulose sponge must be rinsed in clean water after every use. Blot dry with a clean cloth.

### General Conditions Day to Day Soil

Ordinary dirt and smudges can be removed with a mild soap and warm water. Clean from bottom of wall upward. Rinse thoroughly with clean water from the top down using a sponge. Deeply embossed wallcoverings need extra attention in case suds or loosened dirt lodge in depressed surfaces. Dry wallcovering with a soft lint free cloth or towel. For more difficult stains that are only surface deep, the use of a stronger detergent is recommended: however, the manufacturer's instructions should be followed carefully.


Hang wallcovering with a premium quality heavy-duty clear pre-mixed adhesive. Use of a mildew inhibitor in the adhesive is recommended as above instructions. For perforated wallcovering a high quality permable adhesive, such as Roman UltraPlus Pro-550, should be used with the permeable primer. Do not dilute adhesive. Brush an even coat of paste over entire back of wallcovering. Pay particular attention to run over edges so they are sure to be pasted. Book material for ten minutes.

### APPLYING WALLCOVERING TO WALL SURFACE

- If the application is a textured or non-matched wallcovering pattern, reverse hanging of alternate panels is required to ensure color continuity from strip to strip. If the application is a mural it is recommended that every other panel is rotated 180 degrees when printing to minimize the side-to-side color shift that may occur with each printer.
- Determine whether the pattern match is random, straight across, or drop match. Measure the wall height, allowing for pattern match, add 4 inches, and then cut the wallcovering. It will overlap onto the ceiling and the base approximately 2 inches.

### ESTIMATING AREA TO BE PRINTED

### AREA TO BE COVERED




Fig. 1 Illustrating and calculating the area to be covered

- Measure area in complete rectangles. See illustration (fig 1) below.
- Include all doors, windows or cutouts contained within the area to be printed.

### **BLEEDS\***

\*Bleed defines extra image printed beyond the dimensions of the actual wall to accommodate out-of-square corners and to allow the image to be trimmed into place

- Add bleeds to all 4 sides of the measurements.
- Provide a minimum of 2 inches of bleed to each wall.
- For very wide walls, add one inch of bleed for each additional 10 feet of wall

### **SEAMS**

- Wallcovering murals are typically printed in 48 or 50-inch vertical strips
- Typical overlap is with 1 or 2 inches between adjoining panels. Some wall configurations or image content may require customizing seam placement.
- We will discuss the best way to handle seams for your project.
- We will use our best judgment to avoid placing seams in apparently critical image area. NOTE: Always let us know of critical image components that should not contain a seam.




Fig 2: Project Worksheet

### **BEGINNING WORK**

Formal PO: We require a formal purchase order before proceeding with:

- Setup
- Strikeoff
- Final Printing

Work will not begin until we have received a formal PO and payment terms have been met.

### PO GUIDELINES


Instruct your client to refer to our quotation number in their PO. HD Walls is responsible for taking orders and billing the client directly. Do not list Innovations as the manufacturer.

### Purchase Order Must Contain:

- Client contact name and phone
- Bill-to address
- Ship-to address
- Shipping method
- Special packaging requirements
- Shipper account numbers
- Due date for materials on site
- Description of digital media provided, file names and number of files included
- List one file per line item. Use the exact file name as it appears on the file-bearing media.
- Release form authorizing HD walls to reproduce the images listed
- Color matching instructions, color swatches, and other color reference



## DIGITAL PRINTING REQUIREMENTS & PROCEDURES



### **FILES**

Customer provided files must meet or exceed the following conditions:

File type: Adobe Illustrator, Adobe Indesign, Photoshop (PSD, TIFF)

Note: JPG and some other compressed file formats are accepted only with prior approval.

Photoshop files (raster) and Photoshop files placed in Indesign or Illustrator must have a resolution of atleast 72 PPI at the largest size to be printed. Adobe Indesign and Adobe Illustrator files must be supplied with all placed graphics and photos. Fonts must be included or converted to outlines in the original art.

### SUBMITTING FILES FOR PRINTING

Please upload files at: hdwalls.com/upload

If files are larger than 2GB, please contact us and we will make alternate arrangements.

All critical colors must be noted and specified as Pantone or other universal color code. We can match some paint swatches from our swatch library. We prefer that you include physical swatches whenever possible for precision of color match.

We will match all colors specified as part of our pre-press and strike off process.

PRINT READY FILES: Print-ready means your file can be sent directly to the printer as it has been provided. The image can be reproduced with no additional artwork, editing, or sizing (other than simple scaling) required by our art department.

\*There is no set up fees for printer ready files.

### STRIKE-OFF PRINT

Please submit strike-off approvals at: hdwalls.com/approvals

We require a formal approval of a strike off image before final production. Strike off prints usually ship within 5 business days of receipt of the complete PO. We keep a retain image on site so a hard copy sign-off is not required. The client's approval submission at hdwalls.com/approvals begins the final production phase.

Strike off prints bill at \$90.00. Upon the client's approval for printing, the cost of their strike off print is credited back to their order.

**Edits at production time:** Artwork and edits to existing art or colors are billable at \$90.00 per hour. We will estimate time required for changes and request actions to be taken should we discoverthat time required in process exceed that limit. Edits will delay production of finished product. Edits require approval of an additional strike off.

Environmental management at HD Walls includes recycling. HD Walls is always looking for ways to improve our products and this is an opportunity for customer participation in a post consumer recycling program. Let us work together to establish recycled product solutions to reduce landfill disposal. All HD Walls products can be recycled.

The goal of our recycling program is to provide recycled content to assist in gaining

credit within green building certification programs while simultaneously insuring that the introduction of recycled content does not introduce other issues of concern to the product. By carefully controlling and evaluating the selected recycled content materials, the quality can be maintained throughout the entire life cycle of the wallcovering product.

The environmental aspects that recycling initiatives promote includes:

- Landfill avoidance of waste and post consumer wallcovering
- Compatibility in material formulations
- Color control
- Chemicals of concern management
- Create LEED credit eligible materials and diversion of construction waste opportunity


HD Walls has an established a pre-consumer recycling program. This includes materials produced and reprocessed from available manufacturing materials. Recycled content can include pre- and post-consumer materials. For post consumer materials, materials can be returned to HD Walls for re-processing into new wallcovering.

### Limitations.

Contamination is controlled by pre-approving materials being submitted for recycling. This quality control measure is designed to keep incompatible materials from being incorporated into recycled content products. Quality of the final product is not compromised. Some residual contamination is expected, such as drywall paper and adhesive, and can be screened effectively during the recycled content preparation for re-manufacturing.

### Pre-approval for recycling wallcovering.

All manufactured wallcovering will be considered for post-consumer recycling. Replacement of HD Walls wallcovering with new HD Walls product will always be accepted. Pre-approval is requested for recycling competitors' wallcovering products because of formulation differences. Every effort will be made to accept all materials into the recycling program, but only select materials will be converted into new, recycled content wallcovering products. We reserve the right to refuse highly contaminated materials to insure that quality is strictly controlled.



There are two types of recycled material generated from wallcovering products:

- Plastic resin component
- Fiber content from laminates

These materials are separated and included as recycled content for new manufactured products. Recycled content of the new product is measured as a combination of these two components.

### Packaging post-consumer product for return.

All post-consumer wallcovering placed into Gaylord containers or plastic bags can be returned for recycling. These materials will be visually inspected and then processed for component separation. Gaylord containers or plastic bags are used to make handling easier at both the installer and plant location.
